## FREEDOM OF INFORMATION – DECISION NOTICE

Dear Requester

**FOI Reference Number: 000316**

I refer to your email of 21 March requesting information in respect of wheelchair service.

I can confirm on behalf of Great Yarmouth and Waveney, North Norfolk, South Norfolk, Norwich and West Norfolk CCGs and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do hold some of the information that you have requested. A response to each element of your request is detailed below in blue:

- 1. Is your Wheelchair service procured as a separate service, or is it combined with other services such as Community Equipment, Prosthetics etc. If so, which services is it combined with?**

For the five CCGs this is procured as a separate service within a larger contract. The service relates to wheelchair and seating provision only.

- 2. Is your wheelchair service procured as an integrated wheelchair service (i.e. Assessments and approved repair in one contract) or separately as different contracts?**

- 3. Is your provider / providers an NHS organisation or a contracted out non NHS organisation?**

For North Norfolk CCG, Norwich CCG, South Norfolk CCG and West Norfolk CCG the contract holder is an NHS organisation.

For Great Yarmouth and Waveney CCG, the contract holder is a non-NHS organisation.

- 4. What is the name of your current Wheelchair Services provider – or if Approved Repair and Assessments are provided separately, what are the names of the providers for each service?**

For North Norfolk CCG, Norwich CCG, South Norfolk and West Norfolk CCG the service is provided by Norfolk Community Health and Care NHS Trust (NCHC).

For Great Yarmouth and Waveney CCG, the service is provided by East Coast Community Healthcare (ECCH).

**5. Is your wheelchair service exclusive to your CCG?**

See 4 above

**6. If your service is combined with another CCG please provide a list of the CCGs that share this wheelchair service and confirm who is the lead CCG?**

See 4 above, the Co-ordinating Commissioner for the NCHC contract is Norwich CCG and the ECCH contract is solely with Great Yarmouth and Waveney CCG.

**7. When was each part of your wheelchair service (Assessment, Approved Repair, or integrated) last tendered?**

The ECCH contract was subject to a tender in 2018 commencing 1 April 2019.

**8. When does the current contract expire. Please provide details of any potential contract extensions?**

The ECCH contract expires 30 March 2024, with an option to extend the term by 2 years.

The NCHC contract expires 31 March 2024 or 2026 dependant on contract extension.

**9. Please provide the date this Wheelchair service will be next tendered?**

For North Norfolk, South Norfolk, West Norfolk and Norwich CCGs this information is not currently held because this has not yet been decided or agreed.

For Great Yarmouth and Waveney CCG this will be 2023 unless contract extension is awarded.
