I refer to your email of 21 September requesting information in respect of systems spend; copy attached.

I can confirm on behalf of North Norfolk, South Norfolk and West Norfolk CCGs and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do hold some of the information that you have requested. A response to each element of your request is detailed below:

The majority of the information sought is not held by the CCGs. This is because the items specified are medical systems, which the CCG does not require. There are analytic systems that are assessable to the CCG via the Commissioning Support Unit (CSU), however the CCG does not pay for this software directly as this is included within the Service Level Agreement price with the CSU.
